TUITION FEES FOR TAUGHT COMPONENT – €3,600 (1 YEAR)

- 1st Instalment €900.00
On enrolment
- 2nd to 4th Instalment €900.00
Between 1st and 25th January, April and June

Students who enrol for just 1 semester pay for half of the taught component fee (€1,800), in 2 instalments.

TUITION FEES FROM THE 3rd SEMESTER ONWARDS – €2,000 (PER YEAR)

- 2nd to 4th Instalment €500.00
Between 1st and 25th January, April and June

2nd PHASE – RESEARCH – €2,000 (PER YEAR)

Tuition fee for the 3rd cycle and special system for presenting a thesis without enrolling for the study cycle

Between 1st and 25th January, April and June

Payments should be made by debit card by ATM (Multibanco) using the reference numbers available in the student area, on the FDUNL webpage, or at the FDUNL treasury.

Non-payment of fees by stipulated deadlines may lead to the suspension of enrolment and registration, as well as the invalidation of all work done in the academic year to which the non-payment refers.

MERIT SCHOLARSHIPS/DISCOUNTS*

Students who join the 3rd-Cycle Course for the first time in the academic year 2016/2017 will be given a 20% discount as a “merit scholarship”, if the final grade of their admission course is equal to or higher than 18.

Students who have graduated and/or obtained a Master’s degree or PhD at FDUNL enjoy an automatic discount of 10% on fees, in addition to financial discounts.

A 5% discount on the taught or non-taught tuition fee if paid in its entirety when registering or enrolling.

Discounts for the Associação Sindical dos Juizes Portugueses (Portuguese Judges Labour Association) and the Associação Sindical dos Magistrados do Ministério Público (Public Prosecution Service Magistrates Labour Association) – 25% during regular course time.
